## PENFED 10K DREAM SAFE GIVEAWAY OFFICIAL RULES

## NO PURCHASE, CREDIT CARD APPLICATION, OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

## PENFED MEMBERSHIP WILL NOT INCREASE YOUR CHANCES OF WINNING.

## A PURCHASE, CREDIT CARD APPLICATION, OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY: The PenFed 10K Dream Safe Giveaway (the "Sweepstakes") is open only to individuals age 18 or older who are legal residents of one of the 50 United States, the District of Columbia, or Puerto Rico (collectively the "Eligibility Area"), including those permanent legal residents of the Eligibility Area who are currently residing on an overseas United States military installation. Employees, officers and directors of Pentagon Federal Credit Union ("PenFed" and/or "Sponsor") and its parents, affiliates, subsidiaries, advertising and promotion agencies and promotional suppliers (aforementioned individuals and organizations collectively, the "Promotion Parties"), and the immediate family members (spouse, siblings, and children, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible. Void outside of the Eligibility Area and where prohibited. Sponsor's determinations of eligibility are final and may be made at any time. All federal, state, and local laws and regulations apply.

Note that by entering this Sweepstakes, you are agreeing to be bound by these Official Rules and the decisions of the Sponsor which shall be final and binding on all matters relating to the Sweepstakes.

- **2. TIMING:** The Sweepstakes begins at 12:00:01 AM Eastern Time ("ET") on February 1, 2024, and ends at 11:59:59 PM on May 31, 2024 ("Sweepstakes Period").
- **3. TO ENTER:** There are two ways to enter the Sweepstakes: receive one (1) entry into the Sweepstakes by applying and being approved for one of the following PenFed Credit Cards: Gold Visa® Card, Power Cash Rewards Visa Signature® Card, Platinum Rewards Visa Signature® Card, or PenFed Pathfinder® Rewards Visa Signature® Card ("Participating Credit Cards") during the Sweepstakes Period <u>or</u> receive one (1) entry without applying and being approved for a Participating Credit Card by entering online.
  - (a) <u>Approved PenFed Participating Credit Card Application Method of Entry:</u> You will automatically receive one (1) Sweepstakes entry when you apply and are approved for one of the PenFed Participating Credit Cards during the Sweepstakes Period.
  - (b) <u>To Enter Without an Approved Participating Credit Card Application:</u> To enter without applying and being approved for a Participating Credit Card during the Sweepstakes Period, go to <u>giveaway.penfed.org/safegiveaway</u> during the Sweepstakes Period and complete and submit the online entry form.

Regardless of method of entry, there is a limit of one entry per person/email address.

Entries will be disqualified if they are late, incomplete and/or in excess of any stated entry limit. Sponsor's computer will be the official time clock for the Sweepstakes. The use of any device or technique to automate participation in this Sweepstakes, including but not limited to, participation using any bot, macro, script, hack, on-line sweepstakes service or form-filling software (or any other devices or techniques intended to automate any part of participation in the Sweepstakes) is prohibited. Participation by any means which subvert the participation process as described herein will be void. Entries are void if unreadable, inaccurate, incomplete, mutilated, tampered with, forged, irregular in any way, or otherwise not in compliance with these Official Rules. If Sponsor or its designee, in its sole discretion, determines that any participant has used any device or technique to automate or subvert the participation process or participation limits, all participation by that participant will be void and future participation attempts by the participant at issue may be blocked. All submitted information becomes property of Sponsor and will not be returned. Any acknowledgment of receipt of entry does not constitute any representation as to eligibility, selection as a potential prize winner, or is it otherwise binding upon the Promotion Parties in any respect. Proof of submission of entry does not constitute proof of receipt of entry. In the event of a dispute as to the identity of the entrant associated with any entry, the authorized account holder of the email account or phone number associated with the applicable Sweepstakes registration, at time of submission, will be deemed to be the entrant, as applicable. **4. RANDOM DRAWING / PRIZES / ODDS OF WINNING:** On or about June 28, 2024, Promotion Mechanics, Inc., an independent judging organization, will conduct a random drawing at its offices in Newtown, CT, from among all eligible entries received to award two (2) Grand Prizes, each consisting of a Fort Knox Gun Safe, including delivery and installation. Approximate Retail Value ("ARV") of Gun Safe is \$8,000; delivery and installation of Gun Safe is estimated at \$2,000. Total ARV of each Grand Prize is \$10,000. Total ARV of all prizes is \$20,000.

Model and options of gun safe are at the sole discretion of the prize provider. Any difference between the actual value and the stated value will not be awarded. Any costs beyond the \$2,000 delivery and installation allowance are the sole responsibility of the winner. If a winner does not own the home, condominium, apartment or other home structure where the Gun Safe is to be installed, the winner must obtain written permission from the homeowner prior to the prize award, in a format

A potential winner must reply as instructed to identify him/herself, confirm his/her eligibility and ability to accept the prize, and provide his/her complete contact information within three (3) business days following attempted notification, or he/she may be disqualified and an alternate winner selected as set forth above. DISPUTES/GOVERNING LAW: All issues and questions concerning the construction, validity, interpretation and enforceability of these rules, or the rights and obligations of any entrant or the Released Parties in connection with the Sweepstakes, shall be governed by and construed in accordance with the laws of the Commonwealth of Virginia without giving effect to any choice of law or conflict of law rules or provisions which would cause the application or the laws of any jurisdiction other than the Commonwealth of Virginia. Any action or litigation concerning the Sweepstakes shall take place exclusively in the federal or state courts sitting in Fairfax County, Virginia, and you expressly consent to the jurisdiction of and venue in such courts and waive all defenses of lack of jurisdiction and inconvenient forum with respect to such courts.
