PENFED WASHINGTON JUSTICE 10K GIVEAWAY OFFICIAL RULES

NO PURCHASE, CREDIT CARD APPLICATION, OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

PENFED MEMBERSHIP WILL NOT INCREASE YOUR CHANCES OF WINNING.

A PURCHASE, CREDIT CARD APPLICATION, OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY: The PenFed Washington Justice 10K Giveaway (the "Sweepstakes") is open only to individuals age 18 or older who are legal residents of one of the 50 United States, the District of Columbia, or Puerto Rico (collectively the "Eligibility Area"), including those permanent legal residents of the Eligibility Area who are currently residing on an overseas United States military installation. Employees, officers and directors of Pentagon Federal Credit Union ("PenFed" and/or "Sponsor") and its parents, affiliates, subsidiaries, advertising and promotion agencies and promotional suppliers (aforementioned individuals and organizations collectively, the "Promotion Parties"), and the immediate family members (spouse, siblings, and children, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible. Note that by entering this Sweepstakes, you are agreeing to be bound by these Official Rules and the decisions of the Sponsor which shall be final and binding on all matters relating to the Sweepstakes.

- **2. TIMING:** The Sweepstakes begins at 12:00:01 AM Eastern Time ("ET") on July 1, 2022 and ends at 11:59 PM on August 31, 2022 ("Sweepstakes Period").
- **3. TO ENTER:** There are two ways to enter the Sweepstakes: receive one (1) entry into the Sweepstakes by applying and being approved for a PenFed Justice x PenFed Power® Credit Card during the Sweepstakes Period <u>or</u> receive one (1) entry without applying and being approved for a PenFed Justice x PenFed Power® Credit Card by entering online.
 - (a) Approved PenFed Justice x PenFed Power® Credit Card application method of entry: You will automatically receive one (1) Sweepstakes entry when you are approved for a PenFed Justice x PenFed Power® Credit Card during the Sweepstakes Period.
 - (b) <u>To Enter Without an Approved PenFed Justice x PenFed Power® Credit Card Application:</u> To enter without applying and being approved for a PenFed Justice x PenFed Power® Credit Card during the Sweepstakes Period, go to **giveaway.penfed.org/powergiveaway** during the Sweepstakes Period and complete and submit the online entry form.

Regardless of method of entry, there is a limit of one entry per person/email address. Entries will be disqualified if they are late, incomplete and/or in excess of any stated entry limit. Sponsor's computer will be the official time clock for the Sweepstakes. The use of any device or technique to

automate participation in this Sweepstakes, including but not limited to, participation using any bot, macro, script, hack, on-line sweepstakes service or form-filling software (or any other devices or techniques intended to automate any part of participation in the Sweepstakes) is prohibited. Participation by any means which subvert the participation process as described herein will be void. Entries are void if unreadable, inaccurate, incomplete, mutilated, tampered with, forged, irregular in any way, or otherwise not in compliance with these Official Rules. If Sponsor or its designee, in its sole discretion, determines that any participant has used any device or technique to automate or subvert the participation process or participation limits, all participation by that participant will be void and future participation attempts by the participant at issue may be blocked. All submitted information becomes property of Sponsor and will not be returned. Any acknowledgment of receipt of entry does not constitute any representation as to eligibility, selection as a potential prize winner, or is it otherwise binding upon the Promotion Parties in any respect. Proof of submission of entry does not constitute proof of receipt of entry. In the event of a dispute as to the identity of the entrant associated with any entry, the authorized account holder of the email account or phone number associated with the applicable Sweepstakes registration, at time of submission, will be deemed to be the entrant, as applicable. RANDOM DRAWING / PRIZE / ODDS OF WINNING: On or about September 21, 2022, Promotion Mechanics, Inc., an independent judging organization, will conduct a random drawing at its offices in Newtown, CT, from among all eligible entries received to award one (1) Grand Prize: \$10,000 cash to be awarded in the form of a check. While it is the Sponsor's intention that the winner use the prize monies to create a dream gaming setup, the prize will be issued without restrictions. Winner need not be present.

All eligible entries have an equal chance of winning. Odds of winning will be determined by the number of eligible entries received. No prize transfer. No prize substitution except by Sponsor due to prize unavailability, safety or security considerations, or any other reason as solely determined by Sponsor in which case a prize of comparable or greater value will be awarded.

5. WINNER NOTIFICATION: The potential winner will be notified by phone and/or email, at Sponsor's sole discretion. A potential winner must reply as instructed to identify him/herself, confirm his/her eligibility and ability to accept the prize, and provide his/her complete contact information within three (3) business days following attempted notification, or he/she may be disqualified and an alternate winner selected as set forth above. Potential winner will also be required to complete an affidavit of eligibility, a liability release, and (where legal) a publicity release, which must be returned within the time period specified at the time of such request. Proof of identity, age, and legal residence may be required to claim a prize. If Sponsor so elects, a

indirect damages. The Released Parties are not responsible for and shall not be liable for: (a) electronic, hardware or software program, network, Internet, or computer malfunctions, failures, or difficulties of any kind, including without limitation, server malfunction or for any human, typographical, printing or other error relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in the administration of the Sweepstakes, processing of entries; the announcement of the prizes or in any Sweepstakes-related materials, (b) failed, incomplete, garbled, or delayed computer transmissions; (c) late, lost, garbled, misdirected, incomplete, stolen, delayed or misdirected entries or prize claims; (d) inaccessibility of any website in whole or in part for any reason; (e) damage to entrants' or any person's computer, mobile device or other equipment or the contents thereof; or (f) any condition caused by events that may cause the Sweepstakes to be disrupted or corrupted. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Internet entry must be made by the entrant only at the authorized web site address listed in these Official Rules.

- **8. INDEMNITY:** By participating in the Sweepstakes, you agree to indemnify and hold the Released Parties harmless from any and all claims, damages, expenses, costs (including reasonable attorneys' fees) and liabilities (including settlements), brought or asserted by any third party against any of the Released Parties due to or arising out of your entry, or your conduct in creating an entry or otherwise in connection with your participation in this Sweepstakes, including but not limited to: claims for trademark infringement; copyright infringement; violation of an individual's right of publicity or right of privacy; or defamation.

PRIVACY: Information submitted in connection with the Sweepstakes (including the contact information associated with their qualifying checking account application) will be treated in accordance with these Official Rules and Sponsor's Privacy Policy (as may be amended from time to time), available via https://www.penfed.org/privacy-policy, provided, that in the event of any conflict between these Official Rules and such Privacy Policy, the terms and conditions of these Official Rules shall prevail.
- 11. DISPUTES/GOVERNING LAW: All issues and questions concerning the construction, validity, interpretation and enforceability of these rules, or the rights and obligations of any entrant or the Promotion Parties in connection with the Sweepstakes, shall be governed by and construed in accordance with the laws of the State of Virginia without giving effect to any choice of law or conflict of law rules or provisions which would cause the application or the laws of any jurisdiction other than the State of Virginia. Any action or litigation concerning this Agreement shall take place exclusively in the federal or state courts sitting in Fairfax County, Virginia, and you expressly consent to the jurisdiction of and venue in such courts and waive all defenses of lack of jurisdiction and inconvenient forum with respect to such courts. Any and all disputes, claims, and causes of action arising out of or in connection with this Promotion, shall be resolved individually, without resort to any form of class action. You agree to service of process by mail or other method

Headings and captions are used in these Official Rules solely for convenience of reference and shall not be deemed to affect in any manner the meaning or intent of these Official Rules or any provision hereof.
